








#### Hurricane Season June through November



## Lessons Learned – What we can do

- Understand that it is not a matter of <u>if</u> a disaster will happen, but it is a matter of <u>when</u>
- Hazard vulnerability and risk analysis Site Specific
- Emergency Plans Exercised & Tested Not Version 1.0
- Become self-sufficient i.e. Healthcare 98-hour rule of thumb
- Form and maintain relationships with local emergency managers and public officials
- Form alliances with local, regional, and/or national institutions to assist with preparedness, response and recovery




## Community Alliance Initiatives

- National Disaster Recovery Framework (NDRF)
- Goal is to engage recovery stakeholders pre-disaster to facilitate a more expedient and efficient recovery
- Specific component of the framework that addresses natural and cultural resources
- Provides and describes various preparedness strategies and approaches and provides structure to foster coordination among state and federal agencies and nongovernmental partners and stakeholders
