Super Circular and More Training Opportunities

I know some of you expressed an interest in the changes to the Super Circular and how you do contracts and how this will impact potential federal reimbursement. On December 9th, yes the same day as our next LMS meeting, at 1:00 there will be a four-hour class hosted here at our MDFR Training Center.

FL-604 Super Circular – December 9, 1:00 pm – Doral

This course is designed for State, Tribal and local government personnel that manage, or procure contracted services and goods using federal grants.

G-202 Debris Management: December 8, all day and December 9, 8:00 am - noon - Doral

This course provides an overview of issues and recommended actions necessary to plan for, respond to, and recover from a major debris-generating event with emphasis on state, local, and tribal responsibilities. Developed from a pre-disaster planning perspective, the course includes debris staff organizations; compliance with laws and regulations; contracting procedures; debris management site selection; volume-reduction methods; recycling; special debris situations; and supplementary assistance.





Additionally, this course will cover the Super Circular training (abridged), that FEMA has mandated regarding the new procurement procedures for ALL Federal Grants, including all federally funded grants associated to FEMA disaster Assistance Grants.

Mitigate Flu Season

The Florida Department of Health in Miami-Dade County is encouraging everyone to get vaccinated before Halloween to reduce the risk of illness this flu season. Influenza (flu) is a contagious respiratory illness caused by influenza viruses that infect the nose, throat, and lungs and can be spread by coughing, sneezing, and close contact. Flu season typically starts in the fall and peaks in January or February, and can last as late as May.

The Centers for Disease Control and Prevention (CDC) recommends annual influenza vaccinations for everyone 6 months of age or older since flu viruses change. Vaccination is especially important for people at high risk of influenza complications, including: people 65 years and older, pregnant women, young children and people of any age with certain chronic medical conditions.

Miami-Dade Public Works has an online application where you can find Survey Control Points and their elevations. By clicking on the point you can find the elevation and where to locate it on the ground.



Josh Overmyer with the State of Florida CRS program is an excellent resource and we also have a local CRS Users group.

Congratulations to the City of Miami Beach for maintaining their CRS Rating of a 6. With the new manual and criteria this is challenging and quite an accomplishment. The City of Miami Beach has approximately 46,000 flood insurance policy holders and this rating saves them over \$5.7 million annually.
