Congratulations M-D LMS You've Got Class!

Well almost. Since 2013 you have heard me talk about how we were working to get uniform credit for the Community Rating System (CRS) through the LMS. This year we submitted for Activity 510 and 610 credit. We received 211 and 269 points respectively. That is 480 points that each CRS community gets just by being a part of the LMS. So what does that mean? In the CRS program each class (10 classifications in descending order) earns you a 5% discount for your flood insurance policy holders. Each class is 500 points, so the LMS is very close to helping each community get to that next class level. We are so close! Don't worry Yahiritza and I are already looking to see if we can scrape up 20 more points.

As of May 1, 2016 Miami-Dade Communities that participate in the CRS program save flood insurance policy holders \$33,865,986 annually. If we reached 500 points for the LMS that would be 5% or \$1,693,299.30 that we help contribute! Every year! And even though we don't have enough points for a full class yet, maybe this will help push some communities to the next class level.

NFIP Policies

In all communities in Miami-Dade County there are 350,582 NFIP flood policies. Currently 338,476 are in CRS communities or 92.5%. If your community is not participating, please consider getting into the program so we can get discounts for the other 7.5%. The Miami-Dade Office of Emergency Management will be hosting the 2016 Hurricane Exercise on May 18th and we will be hosting a special flood workshop component on the 19th. On the 19th we are bringing in speakers from National Weather Service, South Florida Water Management, Transportation and Public Works, Regulatory and Economic Resources and ITD. We will hold an open discussion on forecasting, monitoring and canal operations, alert and notification, and tools you can use to monitor, strategize and document flooding concerns and response. Mapping LMS Projects

As you all know we have been working on the ability to map LMS projects in WebEOC. Why? So we can show all the great work we have done, we are working on and hope to do one day. Thanks to Aimee Bojorquez from OEM this process has gotten easier. If your address does not show up or if you have a project that is an area and not a point you can now select it on the map with a pointer. I am attaching the instructions to this LMS Bulletin and they have been put in the File Library in WebEOC. When you log into your LMS Board account you can find both that and the overall guidance on how to add projects to the



board. We are still working on the color coding portion of this and we just found out that there will be the ability to display this map publicly as well. We will keep you posted on our progress.

The system had to be re-calibrated due to the high number of projects in areas, so you will see a new look to the map. Due to some geocoding issues, some projects that had been mapped had to be removed* from the mapping tool but the new process is much easier and will reduce any issues with the geocoding. (*No projects were deleted but they may have been "unmapped". We apologize but the system crashed

and this was necessary to get it back up and running.)

The new map will show projects in clusters. To the right is a screen shot that shows clusters of projects. As you zoom in closer or click on a cluster you will get more detailed information (see below).







As you zoom in you will see the individual projects (soon to be color coded by status) (Complete, Underway, Future).

If you click on the individual LMS tag you can get the details of that project.
