Introductions

Kim Bergen welcomed everyone on the conference call. Since our last meeting we had two new institutions (Miami Seaquarium & National Park Service) join the Alliance.

Preparedness Survey

The Southeast Florida Art and Cultural Community Preparedness Survey had 17 participants. Steve will be reaching out to those participants who provided their contact information. The results of this survey were sent as an attachment to the committee members.

By-Law Status

Kim Bergen read through the new bylaws. Copies were provided to the membership for their review.

American Institute for Conservation of Historic and Artistic Works (AIC)

Heritage Preservation was disbanded and the Alliance for Response program was moved to AIC. Jessica Unger is the new director for the emergency management program which includes the Alliance for Response program and the Collections Emergency Response Team (AIC-CERT). Part of the AIC-CERT program includes a 24-hour hotline that conservators can call for free to get advice on emergency protective measures. This hotline was activated for Tropical Storm Erika. Jessica Unger was pleased that we had begun writing our bylaws. She also noted some recent activities of AIC. A Richmond, VA Alliance for Response was formed in July 2015. They will be adding an Alliance in Albany, NY and Biloxi, MS in 2016. AIC will also be added a discussion forum to the Alliance Network website and the ability to subscribe to the different Alliance list servers. They are also planning a series of six webinars in the near future promoting the Alliance.

Florida Association of Museums Conference Presentation

Robin Kilgo reported that the conference had over 200 attendees. Our presentation had about 17 attendees from museums mainly in Central and Northern Florida. The presentation focused on preparedness and response best practices and was well received.
