Strategic Plan Implementation

Steve Detwiler suggested that the following activities in the Strategic Plan be the priorities for 2015:

- Formalize the structure of AFR Miami through the establishment of bylaws.
- Continue to grow the membership to include large and small art and cultural institutions throughout Miami-Dade and Monroe counties.
- Provide presentations and outreach material to existing groups in the counties to educate potential members and partners on the Alliance.
- Promote and partner with existing preparedness campaigns.

Membership Recruitment

The committee members present recommended that doing recruitment activities during Miami's Museum Month in May 2015 will be beneficial. We can coordinate with the Greater Miami Convention and Visitor's Bureau who is running this event. Also for the annual American Institute for Conservation Meeting Lauren Hall can assist with getting the Alliance added to the meeting agenda or plugged in.

Miami-Dade Cultural Affairs Dept. is an associate member of ArtsReady. Currently, ArtsReady is looking at engaging on a State level. Steve Detwiler also informed the committee that Heritage Preservation informed OEM of the possibility of applying for Hazard Mitigation Grant Program funds to further cultural and arts preparedness activities. Deborah Margol offered to assist OEM.

- Kim Bergen will follow up with the PAAM to see if they are still interested in being involved in the Alliance.
